Vendor Guidelines

Complete and return form to Vendor Chair or email cheyennehispanicfestival307@gmail.com by Aug 15, 2025

- 1. Payment must be received before your registration is accepted and the booth space is reserved.
- 2. Bring your own tables, chairs, and canopy if you want one.
- 3. If you set up a canopy, make sure it's weighted down to prevent accidents. Do not stake down your canopy.
- 4. There are no water or electrical hookups.
- 5. Personal generators are not allowed.
- 6. Selling food requires proper licensing from the Cheyenne-Laramie County Health Department and the Cheyenne City Clerk's Office.
- 7. Contact the Cheyenne-Laramie County Health Department and the Cheyenne City Clerk's Office for food permits if you're offering samples or free food or beverage items, and display the permits visibly at your booth.
- 8. Helium/CO2 tanks need approval from the Vendor Chair.
- 9. Set up and unload your vehicles between 8:00 am and 10:00 am on Saturday, Sept 6th. Move your vehicle to the vendor parking area by 10:00 am to avoid towing at your expense.
- 10. Wait until 8:00 pm to start tearing down your booth for everyone's safety.
- 11. The Fire Department, Vendor Chair, and CHISPA Festival Chair have the final say on decisions.
- 12. No refunds will be offered.
- 13. CHISPA Festival 2025 is set to proceed in the event of rain; however, it will be canceled in the case of extreme weather conditions. Given the extensive planning and the dedicated participation of numerous volunteers, please note that there is no rescheduled date.
- 14. Before the event, a mandatory vendor meeting will be held to review rules and booth placement. A map will be provided during the week leading up to the festival.
